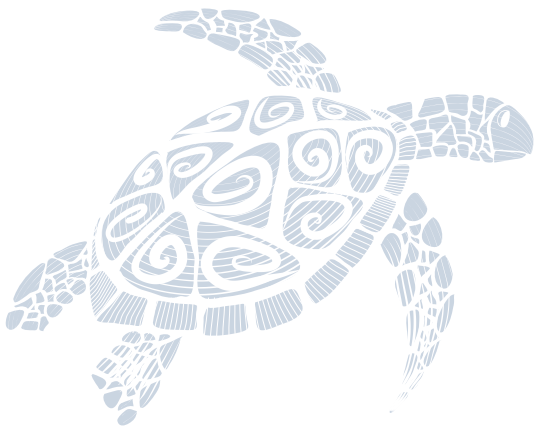

number of recreational opportunities available—including golf, biking, horseback riding, day trips and tours, or simply relaxing with your family and friends in this beautiful and historical setting.

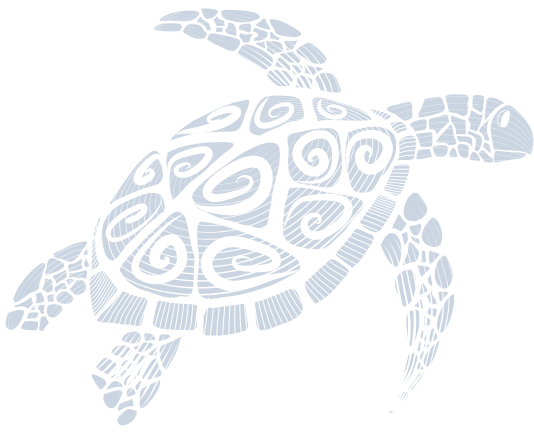
